



MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE NEVADA HOUSING ASSISTANCE CORPORATION ON AUGUST 26, 2016

The Board of Directors of the Nevada Affordable Housing Assistance Corporation, a Nevada non-profit corporation (“NAHAC”) held a public meeting on August 26, 2016, beginning at 9:30 a.m. PST at the following locations:

In the absence of an elected Chairperson (*Sharath Chandra transferred from Nevada Housing Division to Nevada Real Estate Division on 08/12/2016*) or elected Vice Chairperson (*Kolleen Kelley resigned on 06/27/2016*), Mohammad Nemati - Independent Director, acted as de facto Chairperson at the beginning of the meeting until a Chairperson was elected.

1. Call to order, Roll call.

The meeting was called to order by **Mohammad Nemati** as de facto Chairperson.

Present were: Board Members Michael Holliday - Nevada Housing Division Director, Sharath Chandra - Nevada Business & Industry Director, and Mohammad Nemati - Independent Director, de facto Chairperson. **Absent were:** None **Also present were:** Verise Campbell – Chief Operating Officer; Stefanie Sharp, Legal Counsel - NAHAC; and AJ Gavilanes, Secretary/Administrative Assistant.

Members of the public attending in person were asked to sign in, and the sign-in-sheet is attached to the original minutes as Exhibit A.

2. Public comment (1st period)¹: Lina with CSNV inquired as to when there would be an RFP for the new process for HHF. Verise Campbell, COO, asked for confirmation that Lina was speaking of the RFP for the lead counseling agency. Lina confirmed this. Ms. Campbell thanked Lina for the inquiry and responded they were not that far into the process yet, and NAHAC was still doing research and development. Ms. Campbell stated that Lina should hear from her in a few weeks. Lina thanked Ms. Campbell.

Director Holliday moved to approve June 27, 2016, meeting minutes. The Motion was seconded by Director Chandra and approved by unanimous vote.

Director Chandra moved to approve July 14, 2016, meeting minutes. The Motion was seconded by Director Holliday and approved by unanimous vote.

c. Nomination and Election of New President and Chairperson of the Board of Directors (For discussion and possible action)

Director Chandra moved to nominate Michael Holliday as the new President and Chairperson of the Board of Directors. The Motion was seconded by Director Nemati and approved by unanimous vote.

d. Consideration, Approval or Disapproval of modifying the Financial Authorization Matrix to permit the Executive Director/CEO to sign checks and authorize ACH transfers up to \$500.00 without a second signature (checks) or authorization (ACH transfers). (For possible action)

Verise Campbell, COO, gave a brief explanation of the need for this change due to the departure of Matthew Huckins, former VP of Operations and Human Resources.

Director Holliday advised that CJ Manthe, Housing Division Administrator, had also recommended the change.

Director Nemati moved to approve modifying the Financial Authorization Matrix to permit the Executive Director/CEO to sign checks and authorize ACH transfers up to \$500.00 without a second signature (checks) or authorization (ACH transfers). The Motion was seconded by Director Chandra and approved by unanimous vote.

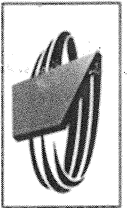

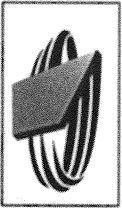
