Hardest Hit Fund: in 2010 the Organization was selected to administer the "Hardest Hit Funds" program of the State of Nevada by the U.S. Treasury. Nevada was awarded over \$169 million in funds available to qualified recipients through a series of federal grants to help Nevada homeowners. Programs available to homeowners are the Mortgage Assistance Program (MAP), the Principal Reduction Program, the Short Sale Program, and the Second Lien Relief Program. MAP participants receive assistance for up to nine months, where NAHAC pays up to \$1,000 per month. Participants in Principal Reduction Program can receive a principal reduction up to \$100,000; \$50,000 paid by the NAHAC in up to three yearly installments, matched by the participant's lender. The Short Sale assistance is designed to help
