MAP provides mortgage payment assistance equal to the lesser of \$3,000 per month or 100% of the principal, interest, tax, and insurance, as applicable (PITI) and any escrowed or non-escrowed homeowner's association dues or assessments, for up to eighteen (18) months, with the purpose of preventing avoidable foreclosures until such time that the borrower retains employment sufficient to meet the demands of satisfying their regular mortgage payment.

Mortgage Reinstatement Assistance Program (MRAP)- Provides temporary financial assistance to eligible borrowers who wish to remain in their homes, but are in imminent danger of losing their home to foreclosure. MRAP provides funds to help income-qualified borrowers cure their delinquent first mortgage loan arrearages, which may also include payments needed to reinstate their loans from foreclosure. Assistance with curing delinquent, non-escrowed property taxes and homeowners' association dues is only available in conjunction with other assistance on the homeowner's mortgage loans.
